Failure to pay by start date will suspend benefits of membership. Re-establishing membership after termination will require payment of that year's initiation fee.

*Payment Plan Option*

If a purchaser wishes to belong to the Country Club but is unable to pay the dues in full please contact the Country Club directly and payment options can be discussed.

*Membership Renewal and Fee Increase Limits*

Annual membership will renew each year automatically with the payment of new dues by the start date anniversary. For those members choosing the Associate Membership, the Full Individual Membership or single year Full Social Membership the Country Club will voluntarily agree to limit any annual increases of the Membership Dues, to no more than the Social Security Cost of Living Adjustment as published each year. In addition the Membership Initiation fee will **not** be charged to automatic renewals.

For those members which choose to sign up either the 3 or 5 year option, the cost of membership is fixed for that period of time and no increases will apply for that time period.
